## EXECUTIVE SUMMARY

As we approach the final stretch towards the 2030 Agenda for Sustainable Development, the urgency to accelerate the implementation of the Sustainable Development Goals (SDGs) has never been more critical. While progress has been made since 2015, persistent challenges continue to hinder equitable and sustainable development at local, national, and global levels. This Newsletter captures the innovative solutions and strategies collaboratively identified by Civil Society Organizations (CSOs) and key stakeholders to leapfrog SDG implementation in the remaining years.

Under the theme "Solutions to Leapfrog **SDG Implementation in the Last Stretch** to 2030." the multi-stakeholder conference held at PrideInn Paradise. Mombasa County, from 9th to 11th December 2024, brought together representatives from counties across Kenya-including Turkana, Makueni, Narok, Embu, Taita Taveta, Kwale, Kitui, Wajir, Nyandarua, Mombasa, Homabay, Samburu, and Nairobi-as well as international participants from Uganda and Finland. Key organizations in attendance included the State **Department for Economic Planning,** Media Council of Kenya, the Private Sector, The Kenya National Bureau of Statistics (KNBS), UNDP, UN Resident Coordinator's Office, Kenya Parliamentary Caucus on SDGs, The

Council of Governors; among others.

A recurring theme throughout the three-day discussions was the importance of localizing the SDGs to national and community contexts. Drawing on best practices from **Finland and Uganda, participants** emphasized the need to adapt global frameworks to local realities. Voluntary Local Reviews (VLRs) emerged as a critical tool for aligning national policies with grassroots efforts, ensuring that communities are active contributors and direct beneficiaries of SDG progress. Strengthening local government engagement and empowering communities to drive development efforts will be essential in overcoming the challenges ahead.

I extend my sincere appreciation to the Inter-Agency Technical Working Group (IATWC) for their meticulous planning and coordination, which ensured the success of this crucial conference. Their leadership in

#### Accelerating SDG Progress: Kenya's Commitment to Inclusive Development

The adoption of the **2030 Agenda for Sustainable Development** in 2015 marked a new era in global development, with 193 UN Member States committing to the **17 SDCs** as a roadmap for people, planet, and prosperity. Rooted in the **Leave No One Behind (LNOB)** principle, the SDCs aim to end poverty, reduce inequalities, and promote sustainable development.

Currently at the **midway point**, progress remains **uneven**, with the **UN SDCs Report 2024** showing that only 17% of targets are on track, while 50% lag behind and 30% have stalled or regressed—particularly on poverty, hunger, and climate action. Growing inequalities, the climate crisis, and geopolitical tensions further threaten SDG implementation, exacerbated by the COVID-19 pandemic.



Kenya has actively tracked progress through **three Voluntary National Reviews (VNRs) and 22 Voluntary Local Reviews (VLRs)**, alongside annual SDG status reports. The **Inter-Agency Technical Working Sub-Committee on SDGs (IATWSC)**, established in 2016, has played a key role in fostering **multi-stakeholder engagement**, policy alignment, and public awareness.

Building on past successes, the State Department for Economic Planning (SDEP), in collaboration with the IATWSC and APC-Colombia, hosted the 2024 Annual National SDGs Multi-Stakeholder Conference in Mombasa under the theme "Solutions to Leapfrog SDGs Implementation in the Last Stretch to 2030." The conference fostered a dialogue, strengthened partnerships, shared outcomes from the Summit of the Future, and culminated in the 2024 SDCs Awards, celebrating outstanding contributions to SDG progress.

## **MULTISTAKEHOLDER APPROACH**

Achieving the **Sustainable Development Goals (SDGs)** requires a **multi-stakeholder approach** that fosters collaboration across government agencies, civil society organizations (CSOs), private sector partners, academia, and local communities. Kenya has embraced this model by integrating SDGs into national policies and programs through inclusive participation, ensuring that no one is left behind.

The Inter-Agency Technical Working Sub-Committee on SDGs (IATWSC), established in 2016, alongside the SDGs Stakeholder Engagement Framework of 2020, drives Kenya's multi-stakeholder engagement approach. This framework provides a structured mechanism for cross-sectoral coordination, policy alignment, and collective action toward SDG implementation.

Kenya's **multi-stakeholder engagement model** has been instrumental in advancing SDG implementation. By aligning **diverse perspectives and resources**, Kenya is creating an enabling environment for sustainable development—**making inclusion the norm**. This conference served as a catalyst for **renewed action and commitment** as the country enters the **final stretch towards 2030**.









#### **CONFERENCE HIGHLIGHTS**

The conference facilitated high-level multi-stakeholder dialogues, bringing together representatives from government agencies, civil society organizations, the private sector, academia, and international partners.
These discussions focused on identifying innovative solutions to accelerate SDC implementation in the last stretch to 2030. Key insights were shared on effective policy frameworks, resource mobilization strategies, and the role of local actors in driving SDG progress.



A notable highlight of the conference was the **SDGs Awards**, which recognized and celebrated stakeholders for their outstanding contributions to SDG implementation. The awards underscored the power of recognition in galvanizing collective action, inspiring individuals and organizations to strengthen their commitment to sustainable development. By showcasing impactful initiatives, the awards encouraged the replication and scaling of best practices across various sectors.



## **PANEL DISCUSSION**

#### 1. CSOs Approach to SDGs Implementation, Monitoring and Review:

During a recent panel discussion, Makueni County was highlighted as a model for localizing the Sustainable Development Goals (SDGs) through the Leave No One Behind framework. With the support of the SDG Kenya Forum, **Community-Based Organizations** (CBOs) have successfully engaged the community in understanding and adapting the SDGs to their local context. Initially, the SDGs felt distant and abstract to many, but through public participation and translating the goals into the local language, the conversation has transformed. Community members are now actively involved in shaping their County Integrated Development Plans (CIDPs), ensuring that marginalized groups are included and that the SDGs are both relatable and actionable at the grassroots level.

Gender equality has been a central focus of these initiatives. The Leave No One Behind framework inherently aligns with gender principles by emphasizing the inclusion of all groups, especially those traditionally excluded. For example, Help Age has worked to ensure that women, particularly elderly women, take on leadership roles in projects such as nurseries. This has challenged gender norms and created new opportunities for women to become champions of change in their communities. By empowering women and youth to lead, these initiatives are making gender equality a lived reality rather than just a principle. Additionally, the integration of gender-responsive budgeting and planning into the county government's CIDPs has been critical in ensuring that gender issues remain central to the development process.

To further simplify communication around the Gender Equality Fund (GEF) commitments, Polycom Girls developed an innovative comic book. This resource breaks down complex concepts into engaging and accessible content, helping more people understand their roles in advancing gender equality. These efforts collectively demonstrate how localized approaches, inclusive participation, and creative communication can drive meaningful progress toward the SDGs.





#### 2. LEVERAGING ON INCLUSIVE DATA FOR COMPREHENSIVE MEASUREMENT OF SDGS: STRATEGIES, OPPORTUNITIES AND CHALLENGES

During this session, it was noted that engaging the community throughout the entire process is crucial—from identifying key data points to be collected to shaping the methods of data collection. Public participation ensures that the data gathered truly reflects the real needs and priorities of the community, fostering inclusivity and accuracy in decision-making.

Data plays a pivotal role in assessing whether resources and policies are effectively reaching the grassroots level and creating meaningful impact. By leveraging data, stakeholders can identify gaps, monitor progress, and refine strategies to address challenges such as food loss and enhance food security at the local level. To ensure robust data validation on Sustainable Development Goals (SDGs), several strategies can be implemented, particularly by fostering collaboration among Civil Society Organizations (CSOs), county governments, and national bodies. This collaborative approach strengthens accountability, enhances data reliability, and drives more targeted and impactful interventions.

Here are some strategies to enhance the integrity and impact of data reporting and ensure the SDCs are implemented effectively:

- Solution Use technology tools like dashboards and digital platforms to share data transparently and allow for real-time validation and feedback from various stakeholders, including local communities, county governments, and national bodies.
- Solution Use indicators that are locally relevant but also align with global SDG targets to facilitate comparison and reporting.
- Push for increased transparency in SDG implementation at the national level by advocating for open data policies.





## **KEY MESSAGES**

UNDP's Role in SDGs Under Agenda 2030

- ✓ Integrator for SDGs: UNDP (United Nations Development Programme) plays a key role in integrating the Sustainable Development Goals (SDGs) into national and local policies and programs, helping countries align their development plans with the global Agenda 2030.
- Support for Member States: UNDP assists member states in domesticating and localizing the SDGs, ensuring that global goals are adapted to local contexts, priorities, and realities. This involves providing technical assistance, policy guidance, and capacity-building to help countries implement and track progress on SDG targets.





#### WAY FORWARD

As we approach the final stretch toward **2030**, **strengthening multi-stakeholder partnerships** will be essential in scaling successful initiatives and fostering an inclusive development agenda. Moving forward, there is a need to **enhance public awareness and engagement**, ensuring that more organizations, youth groups, and local governments are actively involved in SDG acceleration. To uphold the **transparency and credibility** of the SDGs Awards, continuous improvement in the evaluation and selection process is critical. Establishing **clear**, **data-driven metrics** and expanding the diversity of the judging panel will help maintain the awards' integrity while recognizing high-impact initiatives. Additionally, creating a follow-up mechanism to track the progress of past winners can enhance accountability and showcase the long-term impact of recognized efforts. By reinforcing these principles, the **SDGs Awards** will remain a cornerstone of Kenya's sustainable development journey, driving momentum towards achieving the **2030 Agenda**.





## **CLOSING REMARKS**

In wrapping up the conference, Mr. George Awalla emphasized the significance of Voluntary Local Reviews (VLRs) in showcasing the importance of both centralized and localized approaches to SDG implementation. The experiences shared by countries like Finland and Uganda demonstrated how crucial it was to adapt global frameworks to local contexts and how vital it was to learn from diverse approaches moving forward.

Collaboration was not just a theme of the discussions-it was an absolute necessity. The realization of the SDGs depended on all sectors coming together, working hand-in-hand, and leveraging each other's strengths. Whether through public-private partnerships, cross-sectoral cooperation, or multi-stakeholder engagements, participants were urged to commit to working collaboratively to drive the transformation required.

## **CONCLUSION**




















#### **CHALLENGES**




